**Working across agencies,

**Foster children lose
6 months of emotional development
for every move, and most foster
children move more than one time**

(The following five slides show national statistics.)

**1/3 of school-age foster
children are behind their age-
appropriate grade levels**

**66% of youth leaving foster care
have not
completed high school**

10% of foster children earn “Ds” or “Fs” in elementary school;

25% of foster children earn “Ds” or “Fs” in middle school; and

28% of foster children earn “Ds” or “Fs” in high school.

**Educational failure is linked to
increased unemployment
and family problems.**

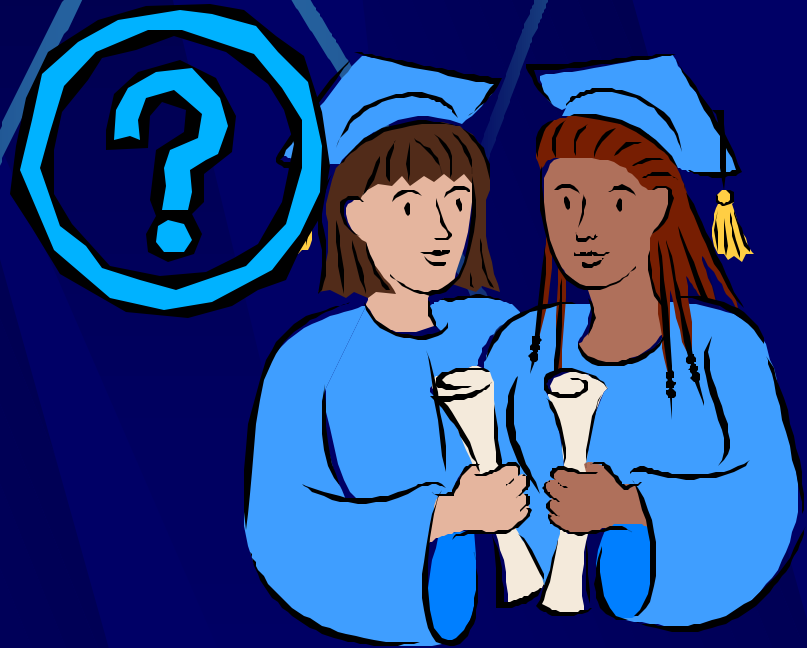
Foster Care and Positive Outcomes

The more stability in foster care the better the adult outcomes for former foster children.

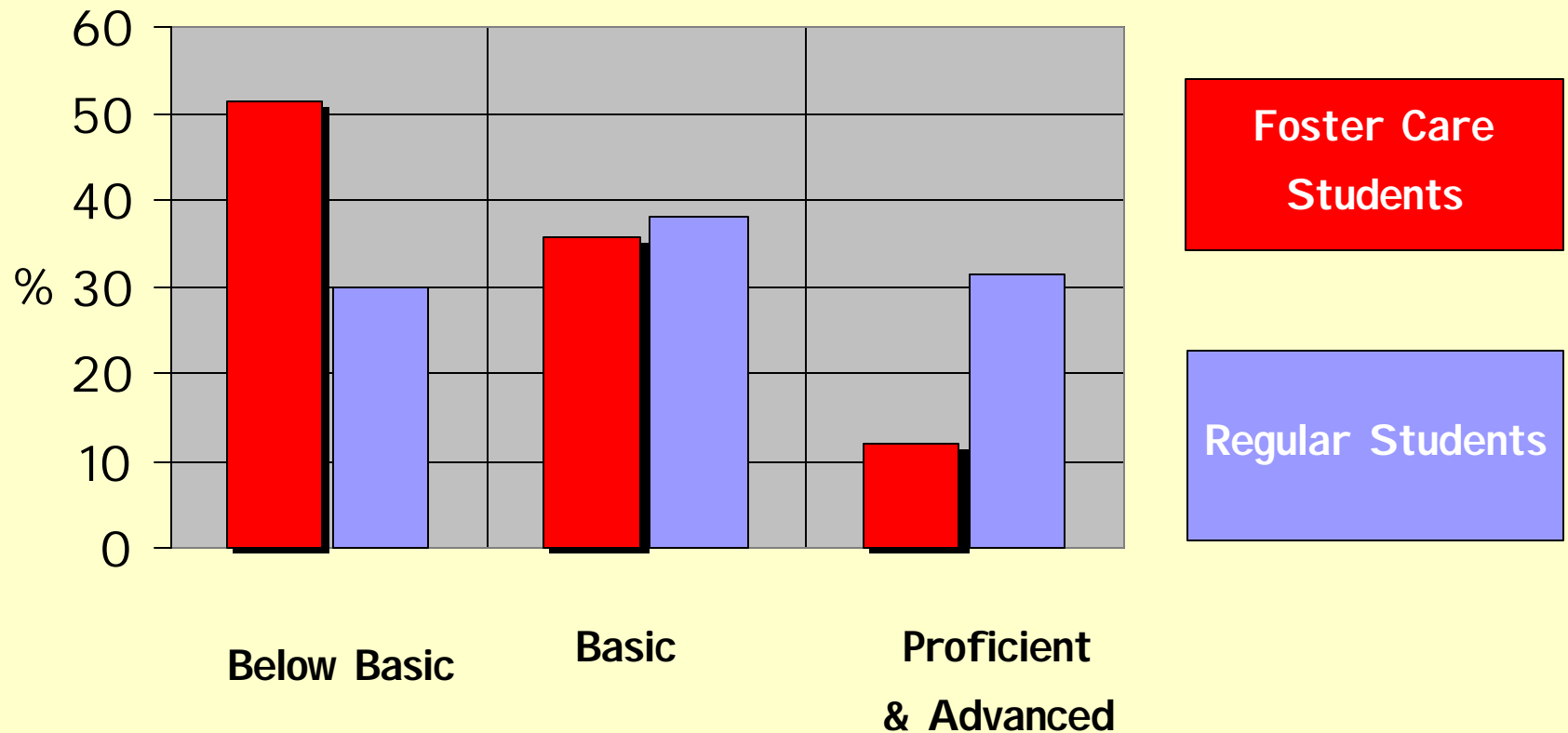


Education and Foster Care in South Carolina— The Nexuskids Initiative

- PACT scores are much lower than statewide averages

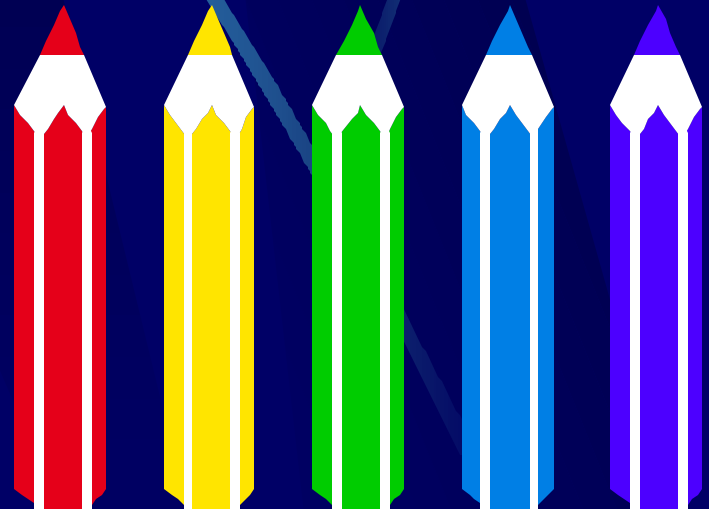


PACT Scores: Foster Care Students vs. All Students



Educational Barriers Identified for Foster Children

- ✓ Too many foster homes and new schools
- ✓ School records are delayed
- ✓ Children have behavior & emotional problems
- ✓ Too few educational assessments completed



Educational Barriers Identified for Foster Children (con't.)

- Child's educational status is not clear to parents, teachers, & DSS
- Foster parents need more support for their child's education
- Transportation
- Enrolling children in school
- Tutoring (expense and availability)
- Lack of knowledge about the child

The Digital Divide

Foster children are being left behind in access to computer technology.

Computer Buddies™*



- Community volunteers approved by DSS
- Encourage computer use by the child
- Educational "coach"
- E-mail friend of child and family

Computer Buddies™*

- Recruited to provide computer support to child and family
- Provides educational encouragement
- Aware of child's progress in school
- Knows when big tests are scheduled
- Acknowledges progress with grades and attendance

Computer Buddies™*



- Meets with parents and child, and takes his or her lead from the child or parent
- Serves various lengths of time
- Helps the child find a new Computer Buddy when time to leave
- Knows how rejection affects the child

Computer Buddies™*

- Is trained to understand confidentiality issues
- Signs DSS confidentiality form
- Lets caseworker know if child discloses information on abuse or neglect or identifies a problem that should be known by DSS
- Completes short monthly progress reports for DSS (with copies to go to Nexuskids and the parents)

Preparing Your County for Computer Buddies™*

- Inform your local foster parents association about the computers (one computer per foster home with school age foster children)
- Brief school district officials and DSS to determine how the schools can help

Preparing Your County for Computer Buddies™*

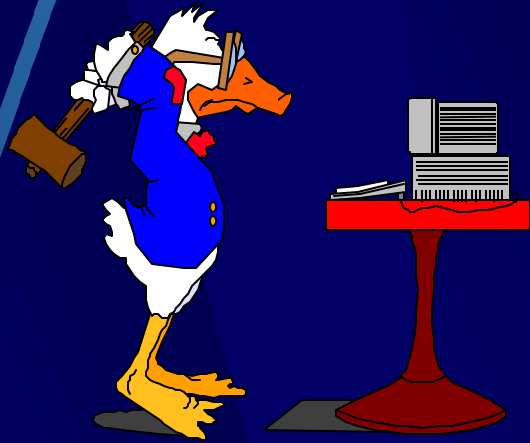
- Identify community partners to help recruit Computer Buddies
- Inform community that computers are the property of the SC Foster Parents Association
- Inform parents that DSS & the SC Foster Parents Association cannot maintain the computer, provide supplies or Internet access

Preparing Your County for Computer Buddies™*



- Identify storage facility that is secure
- Brief foster parents, education, and DSS staff at all levels
- Encourage flexibility in planning—computers will become available at different times

Preparing Your County for Computer Buddies™*



- Identify a DSS Nexuskids Computer Buddies Coordinator
- Identify a Nexuskids Computer Buddies Technical Manager
- Attend Nexuskids training for trainers
